





MESSAGE FROM THE CHAIR

The road safety landscape has changed dramatically in the past decade. Cross-cutting issues related to technology, health, the environment, security and a global economy have emerged, with profound implications on transportation and the ways they do business. At the same time, mobility has become increasingly important to the health of individuals, communities, and countries. It also has significant consequences for economic growth.

In response to this changing transportation environment, businesses are transforming essential processes and adapting to market changes. Supply chains are expanding globally to meet increased demand but are also affected by extreme weather. At the same time, reducing the environmental impact of transportation has become a fundamental priority. Businesses are also transitioning to deliver services online and reach new markets, but the essential need for staff travel and in-person services remains. In

addition, many employers are adapting workplace policies to promote higher levels of health and safety on the job and the road, but also accommodating employees working remotely either on a limited or regular basis.

Similarly, governments are tasked with an increasing array of active transportation options to increase health and mobility while still facing greater demand for affordable and equitable public transport. Automated vehicles present many unknowns, and preparations to manage their testing and influx are challenged by critical knowledge gaps. Moreover, these developments present complex policy and enforcement issues which are difficult to anticipate or address.

In the face of this changing transportation landscape, the need for research and evaluation remains paramount to achieving our intended goals for the future. Evidence is integral to inform decisions and guide action at all levels. In response to this need, TIRF has expanded its network across critical sectors to closely monitor emerging issues and major shifts in priorities. Its ongoing research across traditional sectors of transportation, health and criminal justice continues to be a central focus and, in the past year, has influenced policy and practice related to drug-impaired driving, distracted and aging drivers, cycling, and automated vehicles.

More importantly, TIRF initiatives have underscored the essential role of frontline practitioners, employers, and communities in delivering improvements in health and safety. By embracing the importance of partnerships, information-sharing and coordination across government, industry and non-profits, inclusivity and engagement are recognized hallmarks of TIRF's work.

TIRF has also reached out to new sectors to share knowledge, exchange ideas and experience, and drive innovation. In 2019, relationships were built with automotive and wireless industries, and TIRF partnered with medical professionals to develop new educational technologies. In addition, TIRF collaborated with new communities focused on active transportation, safe cycling and Vision Zero, and worked closely with heavy industry to tackle workplace safety issues.

Research is critical to ensure we are all prepared to adapt to an ever-changing environment. It is a necessary foundation to support long-term growth, facilitate positive change, create efficiencies in social life, and is essential to drive innovation and competition which are the greatest benefits for society. The TIRF Board of Directors is proud to lend its expertise to build such a dynamic and thoughtful organization that truly represents the values of the charitable sector; providing assistance to all. The research undertaken by the TIRF team on an annual basis is a source of leadership across sectors and produces tangible improvements to keep us all safe. MESSAGE FROM THE PRESIDENT

Road safety problems are undeniably complex, and new issues have emerged rapidly in recent years. There have been notable demographic shifts in our population with more older road users who have distinct mobility needs. Continuous technological development has produced more efficient solutions in the form of e-learning programs for drivers, red-light cameras and advanced driver assistance systems. But at least some of these technologies have increased distractions and/or inadvertently encouraged risk-taking.

There have also been noteworthy changes to road safety legislation relating to the legalization of marijuana, as well as competing initiatives to increase and decrease speed limits in various parts of the country. Discussions about regulations for cyclists as well as pedestrians who can pose risks on the road when engaging in unsafe behaviours are ongoing and contentious. This has become more pronounced with cities and regions adopting new strategies to reduce deaths and serious injuries to zero because these initiatives have impacted local regulations in a variety of ways.

Moreover, the face of transportation is continuously evolving. Reliance on active modes of transportation is increasing while several new modes of transportation have emerged in the form of ride-sharing vehicles, automated vehicles and e-bikes. Ultimately, these developments have the potential to fundamentally change priorities in the road environment.

While these issues are diverse and varied, the implications of them are shared. Knowledge is key to keeping pace with changes in the road safety environment, and there is much to be learned from research as well as ways it is implemented in practice. These two elements are essential to tackle road safety problems more efficiently and effectively than ever before.

For almost 60 years, TIRF has been a leader in defining issues, generating new knowledge, and working with stakeholders in research, policy and practice to effect change in how we think about, and deal with, road safety priorities. In the past two decades, our work has increasingly focused on projects that harness the power of research and practice, and 2019 was no different.

TIRF worked closely with public health offices in Canada to design a web-based assessment tool to help communities and schools implement strategic road safety plans. We collaborated with police services in Canada to underscore the fundamental importance of road safety enforcement and shared the latest research with frontline officers. In addition, TIRF delivered community forums on distracted driving with funding from The Co-operators, as well as a series of safe driving forums across the country with support from Labatt Breweries. These are just a few examples of TIRF projects that build bridges between scientific research findings and real-world implementation.

Teamwork within TIRF, and networking with like-minded organizations representing different sectors are the foundation of TIRF's success in reducing deaths and injuries due to road crashes. This approach enables us to anticipate the needs of road safety stakeholders and meet them in ways that generate new knowledge and useable solutions to make roads safer for all Canadians.

TIRF EVENTS & COMMUNITY FORUMS

Road Safety, Enforcement & Court Testimony Workshops

TIRF delivered two road safety, enforcement and court testimony workshops for traffic officers in Saanichton, BC in partnership with the Victoria Police Department and in Toronto, ON hosted by Labatt. These workshops were made possible by donations.





These free interactive workshops to police services shared the latest investigative tools to enforce road safety laws and testify in court, discussed the effectiveness of countermeasures to reduce risky behaviours, and, highlighted

innovative traffic enforcement strategies and their effects on crashes.

Distracted Driving Community Forums

Community members were invited to talk to road safety professionals and first responders

about distracted driving. Attendees were encouraged to ask questions, talk about their experiences and discuss opportunties to protect drivers, cyclists and pedestrians who share their roads.

BikeMaps



The Traffic Injury Research Foundation and the University of Victoria have created the BikeMaps.org Toolkit, with funding from the Public Health Agency of Canada. BikeMaps. org is a citizen web-mapping surveillance tool to report bicycling incidents and has been successfully delivered in nine cities across Canada. The lessons learned from this project have been incorporated into a Toolkit to help municipalities and local cycling advocacy groups bring BikeMaps.org to their city and help increase physical activity through the promotion

of safe and accessible cycling. The Toolkit contains four factsheets, including Best Practice Recommendations for Implementation of BikeMaps.org, Strategies for Creating Sustainability Through Stakeholder Engagement for BikeMaps.org, Outreach Tips for Implementing BikeMaps.org, and Techniques for Tracking Impact of BikeMaps.org. CONTINUING PROGRAMS

Canadian Coalition on Distracted Driving



In 2019, the Canadian Coalition on Distracted Driving (CCDD), led by TIRF & DIAD in collaboration and partnership with The Co-operators® held it's 4th annual meeting in



Regina, SK. More than 15 member organizations and 26 stakeholder organizations were represented including



government, law enforcement, health, academia, community organizations, as well as representatives from the insurance, automotive, trucking and forestry industries.

The CCDD released two new fact sheets and two infographics this past year:

Distracted Driving Technology Framework: Overview aimed to increase understanding of technologies designed to mitigate distracted driving and their role reducing distracted driving. To help determine the impact of new technologies on driver distraction, this framework clearly defines key questions that should be asked as part of any assessment of these technologies.

Distracted Driving Policies & the Transportation Industry takes a look at how employers in the trucking industry recognize their critical role in prioritizing strategies to prevent distracted driving among employees and protect them from other distracted drivers on the road. This fact sheet compares prevention costs to crash costs and describes the potential impact of distracted driving collisions on employers.

Distractions on the Road & Hands-free Technologies & Driving infographics are eye-catching, colourful and relatable with a focus on topics within the issue of distracted driving that are commonly misunderstood and raise awareness to increase road user safety by sharing evidence-based facts and simple tips.

DROP IT AND DRIVE®

During 2019, TIRF's Drop It And Drive® education program delivered its message across Canada and the United states through seminars, school presentations, events and community engagement activities:

- > Delivered 32 youth presentations, including three donor-sponsored presentations, at 30 schools in Ontario and British Columbia to over 5,200 students in grades 6-12.
- > Developed new education programs for elementary and middle schools with a focus on pedestrian safety, passenger roles and responsibilities and road safety best practices.



- > Attended and exhibited at the Governors Highway Safety Association (GHSA) 2019 Annual Meeting, Imagining the Future: Advancing Traffic Safety through Technology and Innovation, August 24-28 in Anaheim, CA.
- > Facilitated two community distraction forums, featuring custom DIAD seminars, in Ontario and British Columbia.

TIRF USA UPDATE

Road Safety Monitor: Alcohol-Impaired Driving in the United States, 2019

TIRF USA, in partnership with TIRF in Canada, released the third annual Road Safety Monitor (RSM) on alternatives to alcohol-impaired driving, sponsored by the Anheuser-Busch Foundation. This poll takes the pulse of the nation on the alcohol-impaired driving issue by means of an online survey of a random, representative sample of American drivers





aged 21 years or older. A total of 2,526 drivers in the U.S. completed the poll in September 2019. This fact sheet provides a general overview of key results related to the prevalence of alcohol-impaired driving, reasons for engaging in this behavior and characteristics of drivers, as well as concern about this and other road safety topics.

TIRF CANADA'S GLOBAL REACH

Notes to Summary Financial Statements Year ended December 31, 2019

The Traffic Injury Research Foundation of Canada (the "Foundation") is incorporated without share capital under the Canada Corporations Act. Effective September 9, 2013, the Foundation continued their articles of incorporation from the Canada Corporations Act to the Canada Not-for-Profit Corporations Act. The Foundation is registered with Canada Revenue Agency as a charitable organization and is tax exempt under the Income Tax Act (Canada).

1. Summary financial statements:

The summary financial statements are derived from the complete audited financial statements, prepared in accordance with Canadian accounting standards for not-for-profit organizations in Part III of the CPA Canada Handbook – Accounting, as at and for the year ended December 31, 2018.

The preparation of these summary financial statements requires management to determine the information that needs to be reflected in the summary financial statements so that they are consistent, in all material respects, with or represent a fair summary of the audited financial statements.

These summarized financial statements have been prepared by management using the following criteria:

- (a) whether information in the summarized financial statements is in agreement with the related information in the complete audited financial statements; and
- (b) whether, in all material respects, the summarized financial statements contain the information necessary to avoid distorting or obscuring matters disclosed in the related complete audited financial statements, including the notes thereto.

Management determined that the statement of changes in net assets and the statement of cash flows do not provide additional useful information and as such has not included them as part of the summary financial statements.
